Some months ago we decided to try your system with two units. We were impressed and soon added five more. Tomorrow I will be ordering two more.

We were interested in the system for two primary reasons. First, over the last several years, we have had at least four pieces of equipment stolen. The total value of this equipment is approximately \$350,000.00. Through depreciation and deductibles, our out of pocket expense has been significant.

The second reason is the difficulty in keeping track of smaller pieces of heavy equipment. It wasn't unusual for us to spend hours looking for a backhoe or skid steer that we simply lost track of. Vehiclepath has solved this problem.

As if that wasn't enough, the best part of the story goes like this:



I called the local police and filed a report, and then the sheriff's department, and told them EXACTLY where to find the equipment. They found our unit and six more pieces of stolen equipment. Furthermore, the police are sure that this will solve numerous cases, and will likely lead to a major buyer of stolen goods. Our skid steer was back on the job by noon.

I have enclosed two articles from local media for your enjoyment. The local television stations covered it, as well. The local sheriff stood on the steps of the jail and boasted about the joint investigation with the City of Chattanooga police. We're getting a huge laugh over this. We think a reward is in order, or at least a thanks from the detectives that look like heroes, but we aren't holding our breath.

Keep up the good work. Maybe we could rep for you. We've already generated interest from some of our friendly competitors.

Stolen Heavy Equipment Found At Ringgold Residence

Over \$313,000 in stolen heavy equipment was found at the home of a Ringgold man, Catoosa County Sheriff Phil Summers announced.

Dale Lewis Ramey, 48, of 2848 Three Notch Road, was taken into custody.

The Catoosa County Sheriff's Office, the Hamilton County Sheriff's Office, and the Chattanooga Police Department Auto Theft Division completed a joint investigation Monday morning which led to the recovery of several pieces of heavy equipment with a value of more than \$313,000, officials said.

The law enforcement agencies recovered seven pieces of heavy equipment at the Ramey residence, Sheriff Summers said.

The heavy equipment consisted of three John Deere tractors, three Caterpillar dozers, and one International dump truck.

Sheriff Summers said the equipment recovered was stolen from Whitfield County, Hamilton County, Chattanooga, and Manchester, Tn.

Ramey was arrested at the scene and is being housed at the Catoosa County Detention Center on seven counts of possession of stolen property. No bond has been set.

Sheriff Summers said the investigation will continue.

He said, "We are in hopes of recovering additional stolen property in regards to this case."

Sheriff Summers said Ramey is also wanted in Hamilton County on outstanding charges.

RINGGOLD, GA. Officers recover heavy equipment

A joint investigation by the Catoosa and Hamilton sheriffs' departments and Chattanooga police led Monday to the recovery of seven pieces of heavy construction equipment valued at \$313,000, Catoosa Sheriff Phil Summers said.

He said three Caterpillar bulldozers, three John Deere tractors and an International dump truck were recovered at 285 Crystal Lane in Ringgold and Dale Lewis Ramey, 48, of 2848 Three Notch Road in Ringgold, was arrested at the scene. He was booked on seven counts of possession of stolen property. No bond had been set Monday evening.

Sheriff Summers said the equipment had been reported stolen in Whitfield County, Hamilton County, Chattanooga and in Manchester, Tenn. An investigation is continuing.

CLEVELAND, TENN. Bradley hires 3 firefighters

Three additional firefighters authorized earlier by the Bradley County Commission have been hired, County Fire Chief Dewey Woody said Monday.

The new hires bring the full-time, paid department to 18 employees, with 15 firefighters, a chief, an inspector and an administrative assistant.

The full-time force is backed up by a force of volunteers at seven stations around the county.

CHARLESTON, S.C. Taylor's son gets 1 year in prison

The son of former Georgia Lt. Gov. Mark Taylor pleaded guilty Monday to felony drunken driving in a crash that killed his best friend, and he received the minimum one year prison sentence under state law.

Fulton Fletcher Taylor, 23, was driving a sport utility vehicle when it hit a wall on an Interstate 26 ramp and flipped, throwing his friend from the vehicle.

Joseph Victor Gennert, 22, of Charleston, was killed in the August 2005 accident. Authorities have said the two men ran up a bar tab of \$186 before the crash.

"I am sorry for the pain and sorrow I have caused," Taylor said during his plea hearing, adding, "Joe's death is my fault."

Gennert's mother, Anna, asked Circuit Judge Perry Buckner not to give Taylor any jail time, but the judge said state law required at least one year in prison.

CLARKSVILLE Body of second fisherman found

Two fishermen on Kentucky Lake found the body of a boater missing for two weeks.

Steve Medford's body was discovered about 12:30 p.m. CDT Sunday, and his widow, Joeline Medford, said she hopes money donated to a fund can help buy special sonar equipment to aid in future searches.

Medford and his brother-in-law Larry Every disappeared March 3 while crappie fishing from a boat. Mr. Every's body was recovered the next day.
